**APPLICATIONS ARE INVITED ONLINE FOR EXTENSION/RENEWAL OF PROVISIONAL AFFILIATION INCLUDING SANCTION OF ADDITIONAL SECTIONS FOR THE ACADEMIC YEAR 2023-24 FOR BOTH GENERAL AND VOCATIONAL STREAMS**

Online applications are being invited in the prescribed format from the managements of existing Private Aided / Unaided Junior Colleges including Composite Colleges / Co-operative / Incentive / Model Schools / APSWR / APTWR / APRJC / MJPAPBC Welfare / KGBVs / High School Plus offering Two Year Intermediate Courses in the State of Andhra Pradesh for Extension / Renewal of Provisional Affiliation for the Academic Year 2023-24 for both General and Vocational Streams, including sanction of Additional Sections if any over and above the Original Sections that were already sanctioned in the Letter of Intent and Provisional Affiliation Order.

The Online application form in this regard will be available in <http://bie.ap.gov.in> from 08.12.2022 onwards and the managements can access the website with their Jnanabhumi Login Credentials. The management should invariably fill up all the fields of the application and upload the required documents duly **scanning the Originals in Colour**. A video with the demo of the Portal will be made available in the Website for better understanding of the process.

The managements have to submit proposals through Online only. Manual proposals if any submitted directly in the Head Office or in the RIO Offices will summarily be rejected without any notice.

It is to be noted that without referring to the previous requests of the managements for renewal of affiliation of their Colleges, this Notification is being issued for receiving applications afresh from the managements for renewal of affiliations and for sanction of additional sections for the Academic Year 2023-24.

The following are the Timelines for strict compliance and no further extension will be allowed under any circumstances.

1. Online Access for submission of Applications : 08.12.2022 to 23.12.2022
2. Submission of Applications with a fine of Rs. 10,000/- : 24.12.2022 to 30.12.2022
3. Inspections by the RIOs concerned : 15.12.2022 to 03.01.2023

4. Scrutiny at BIEAP : 17.12.2022 to 05.01.2023
5. Communication to Colleges for Rectification of Shortfalls (Show Cause) / enabling of Option For payment of Affiliation Fee : 20.12.2022 to 06.01.2023
6. Time for Rectification of shortfalls : 3 Months from the issuance of Show Cause Notice
7. Payment of Affiliation Fee : Within 15 Days from the Date of enabling of Payment option in the College login.
8. Issuance of Affiliation Orders by the BIEAP : Up to 06.04.2023
9. Issuance of Disaffiliation Orders by the BIEAP : On or Before 06.04.2023
10. Display of List of Affiliated Colleges For the A.Y 2023-24 in the BIE Website/RIO Offices/Public Domain : 07.04.2023

The managements of the Colleges are hereby informed that Affiliation order that will be issued for 2023-24 shall be considered as Fundamental document for Admission and Examination Process for that Academic year and hence colleges shall not initiate admission process in any form, without obtaining Affiliation Orders for the A.Y 2023-24 and an undertaking to that effect shall be uploaded by the College managements in the manner prescribed which will be made available in the affiliation portal. Any claims that will be raised later in this regard by the managements by violating or non-complying with these directions will not be entertained

Further colleges shall conduct the admission process strictly in accordance with the Admission Schedule that will be notified by the BIEAP.
